# International Year of Sanitation 2008 Action plan for Nigeria Roles for LGA

- Increase funding levels for sanitation and hygiene programmes from existing budgets
- Support the creation of environmental health clubs in primary schools
- Promote the formation of sani-centres in communities
- Construct sanitation and hand-washing facilities in schools, health centres & public spaces
- Conduct high-profile hand-washing campaigns
- Create LGA WASH Units/Departments
- Draft and enforce bylaws at LGA level to support sanitation and hygiene promotion
- Construct public toilets and latrines in markets, motorparks and other public spaces through directly funded projects and/or projects with private sector entrepreneurs (PPPs)

## National Water Sanitation Policy, 2004

- National Water Supply and Sanitation Policy approved in 2000., but did not address Institutional roles and financing mechanism of the sanitation sector
- National Water Sanitation Policy 2004 seeks to provide a framework for the sustainable development and management of appropriate sanitation services and hygiene education at all levels.

#### **Highlights**

- 100% sanitation coverage by 2025.
- Demand Responsiveness approach
- People will invest in providing sanitation facilities for themselves if they
- Creation of demand for improved sanitation.
- Each household shall be responsible for owning, appropriate use and maintenance of a sanitation facility for the disposal of human waste.

#### National Water Sanitation Policy, 2004

- It shall be obligatory for Federal, State and Local Governments to make yearly budgetary provision with timely release for the promotion of sanitation activities.
- Vote for water sanitation of an amount, which is equivalent to not less than 15% of their annual appropriation for water supply to implement sanitation programmes.
- There shall be Local Government Steering Committee on water sanitation with membership of all departmental heads and representatives of religious leaders, traditional leaders, civil societies, women groups, youth groups etc.
- Establishment of a Sanitation Unit within the Water and Sanitation Department by each Local Government to co-ordinate and facilitate the planning, implementation and management of

## National Environmental Sanitation Policy

- Approved by Government on 26th February, 2005
- 2. Goal: is to ensure a clean and healthy environment by adopting efficient, sustainable and cost-effective strategies, to safeguard public health and wellbeing in line with the national development objectives.
- 3. It sets specific targets as follows:
  - a. Enact all relevant legislation required for policy implementation by 2005.
  - b. Increase access to toilet facilities by 25% in public places and 50% in households by 2006; and 75% and 100% respectively by 2010.
  - c. Increase sanitary management of sewage and excreta by 25% in 2006 and 75% in 2010.
  - d. Institute School Sanitation Programmes in 50% of schools by 2006 and 100% by 2010
  - e. Extend present water supply and wastewater services coverage to 80% of the population by 2007, 100% by 2011 and to sustain full coverage beyond 2011.
  - f. Increase private sector participation in Environmental Sanitation services delivery by 20% in 2006 and 75% by 2010.
