

SEMESTER ONE CUSTOMER SURVEY SYNTHESIS REPORT FOR LAGOS
ISLAND/VICTORIA ISLAND DISTRIBUTION SERVICE AREA

- 1. INTRODUCTION:** This is a report on the first semester survey of the opinions of water consumers in the Lagos Island/Victoria Island distribution service area of the Lagos State Water Corporation (LSWC) carried out by The Better Society Foundation (TBSF) between March and April, 2009. The survey covered water consumers in Lagos Island, Ikoyi, Victoria Island, Victoria Island Extension and Lekki who are served by the LSWC. It also covered water consumers in Lagos Island, Ikoyi, Victoria Island, and Lekki who are not served by the LSWC. The survey was carried out in accordance with the mandate of the LSWC as contained in the contract document.
- 2. SURVEY DESIGN METHODOLOGY:** With the aid of street maps and details of sub-distribution areas provided by the LSWC headquarters and on field descriptions given by LSWC offices in the service area, a survey plan was drawn up by TBSF consultants which detailed five supervisors and 10 trained enumerators to cover various aspects of the distribution service area. This was to ensure sufficient spread and representation in the survey as well as minimise time wasted in tracing streets. The personal interview method was utilised along with a questionnaire pre-agreed and pre-tested in Onikan- Lagos
- 3. FORMAT OF QUESTIONNAIRE:** The questionnaire for the served population was designed to cover the following sub-areas:
 - a. Water Service issues
 - b. Service reliability and performance
 - c. Health related issues
 - d. Drinking water consumption behaviour
 - e. Complementary / Alternative sources of water
 - f. Consumers' participation, billing, metering and other institutional matters.
 - g. Water and sanitation

On the other hand the questionnaire for the un-served population covered only the following issues:

- a. Water availability issues
- b. Health and sanitation issues
- c. Projections

- 4. SAMPLE SIZE:** A sample size of 200 (two hundred) for the served population and 50 (fifty) for the un-served population was found adequate even though the population of the distribution area covered may have suggested a higher sample size. This was because water availability issues simply require a representative but well spread sample.
- 5. RESULT OF SURVEY:** The outcome of the survey is hereby submitted in statistical format on several tables. (See attached tables detailed in percentage format)
- 6. CRITICAL ISSUES FROM SURVEY:** We would like to draw your attention to the following critical issues arising from the survey.

Served Population

- a. **Water supply in the service area:** A significant percentage of respondents in the distribution service area claimed that they have not been served water in the last five years (Lagos Island-35.42%, Ikoyi-15.63%, Victoria Island-40.82%, Victoria Island Extension-44.44% and Lekki-6.82%) See consolidated report page 2, item 5. Similarly a significant percentage of respondents claimed that they are not supplied at all even though connected (Lagos Island- 35.42%, Ikoyi-37.50 %, Victoria Island-65.31 Victoria Island Extension- 33.33, Lekki-25.00%). See consolidated report page 3, item 10 Lastly the respondents assert that water supply is their utmost consideration and are not that bothered with other issues like billing etc (Lagos Island-66.67, Ikoyi-78.13, Victoria Island-65.31, Victoria Island Extension-48.15 and Lekki-27.27) See consolidated report page 5, item 4.
- b. **Water quality issues:** A very significant percentage of respondents were willing to pay more for water if the quality improves (Lagos Island-77.08, Ikoyi-81.25, Victoria Island- 73.47, Victoria Island Extension- 92.59 and Lekki-75.00). See consolidated report page 7, item 2. Similarly a significant percentage of respondents claimed that there was health risk posed by water supplied by LSWC (Lagos Island-43.75, Ikoyi-50.00, Victoria Island- 34.69, Victoria Island Extension- 29.63 and Lekki-38.64). See consolidated report page 7, item 3.

- c. **Leakage:** A significant percentage of respondents had not experienced or observed incidence of water leakage in the distribution area (Lagos Island- 64.58, Ikoyi-78.13, Victoria Island- 81.63, Victoria Island Extension- 85.19 and Lekki-72.73). See consolidated report page 2 item 8.
- d. **Billing Issue:** A significant percentage of respondents considered price paid for water to be moderate (Lagos Island-39.58, Ikoyi-25.00, Victoria Island- 10.20, Victoria Island Extension- 33.33 and Lekki-9.09). See consolidated report page 5 item 3.
- e. **Main improvement LSWC water consumer's want:** Among contending issues the majority of consumers would like to see an expansion in water distribution network (Lagos Island-72.92, Ikoyi-59.38, Victoria Island- 57.14, Victoria Island Extension-59.26 and Lekki-43.18). See consolidated report page 16 item 13.

Un-served Population

- a. **Source of drinking water:** Sources of drinking water varied in the service area as follows: Dug Well (Lagos Island-72.92, Ikoyi-59.38, Victoria Island- 57.14, and Lekki-43.18). Bore Hole (Lagos Island-20.00, Ikoyi-40.00, Victoria Island- 40.00, and Lekki-40.00). Water Tanker supply- (Lagos Island-0%, Ikoyi-33.33, Victoria Island- 6.67, and Lekki-10.00). Kegs-in-Cart (Lagos Island-10.00 Ikoyi-6.67, Victoria Island- 6.67, and Lekki-0%). Sachet Water (Lagos Island-50%, Ikoyi-13.33, Victoria Island- 6.67, and Lekki-0%) Bottled Water (Lagos Island-0%, Ikoyi-6.67, Victoria Island- 20.00, and Lekki-50%) See consolidated report for un-served population page 1 item 2.

7. COMMENDATION TO LSWC STAFF IN THE DISTRIBUTION SERVICE AREA:

- a. **Management Staff:** We would like to use this opportunity to express our sincere appreciation to the management staff of LSWC offices in Lagos Island, Ikoyi, Victoria Island, Victoria Island Extension and Lekki for the wonderful cooperation they extended to us before, during and even after the survey exercise.

b. Staff: We observed that the staff maintained a very cordial relationship with the public in all the locations. In particular we were initially unable to carry out the exercise in some parts of Lagos Island. Our team were only allowed when LSWC staff in Onikan-Lagos escorted them. They opened up doors for us wherever we went.

8. OBSERVATIONS ON QUESTIONNAIRE: Although all the consultants accepted the questionnaire format from the onset, on field trial has shown conclusively that it is too comprehensive and too lengthy. We believe that the questionnaire should be pruned down to not more than 20 (twenty) key questions for the served population and not more than 10 (ten) for the un-served population. This will no doubt eliminate the drudgery faced by respondents and engender more willingness on the part of the respondents as well as more accuracy on the part of the enumerators.

9. CONCLUSION: We believe that the results will help the corporation improve on its service delivery in spite of formidable challenges posed by the ever-expanding population and several ongoing construction works in the service area.
