#### The Lagos State Power **Sector Initiative**

Recently, the Lagos State Government signed an agreement with two power producing firms, the Enron Power Nigeria Limited and Yinka Folawiyo Power Limited. The initiative will lead to the production of 90 Megawatts (MW) of electricity by October. This represents about 20 percent of current output of NEPA in Lagos State. If everything goes according to plan, in the long run, power generation in Lagos State by the private producers will rise to 560 MW is far in excess of the estimated 250 MW demand of Lagos

This initiative is a welcome development. Electricity is critical to economic growth. This is because it is both an intermediate input into industrial production and a final demand for household. It affects the welfare of the people. Yet, the electricity supply statistics in Nigeria is extremely poor. #### **Attacks On Police Stations**

At least three police stations were attacked between August 21 and 22, 1999/ Two of them the Upper Iweka Police post and another at Nkpor, both in Onitsha, were razed by protesting traders over the burglary of about 14 of their shops The third, the Apapa Divisional Police headquarters, was attacked by irate Ijaw youths who forcefully release three of their kinsmen who were earlier arrested and detained there.
